In exercise of powers conferred upon me under sub-section (3) of section 3 of the West Bengal Sales Tax Act, 1994, hereinafter referred to as the Act, and in accordance with provisions contained in clause (d) of Paragraph 2 of Finance Department Memorandum No. 820-F.T. dated 02.06.2015, it is hereby ordered that—

- (a) the persons posted in Large Taxpayer Unit shall have jurisdiction for exercise of powers in terms of sub-section (4) of section 3 of the Act over the dealers mentioned in **Annexure A** attached to this order;
- (b) the jurisdiction over the dealers mentioned in **Annexure B** attached to this order shall be exercised in terms of sub-section (4) of section 3 of the Act by the persons posted in the respective Charge, as mentioned in column (8) of Annexure B against each such dealer; and
- (c) all the existing registered dealers under the jurisdiction of Large Taxpayer Unit, except those mentioned in Annexure B, shall continue to be under the jurisdiction of Large Taxpayer Unit.

This order will take effect from 23.08.2016.
