**Subject: Allotment of duties of Special Commissioners and Additional Commissioners  
posted in different Units of Bureau of Investigation**

In view of the reorganisation of Bureau of Investigation in terms of Notification No. 795-F.T. dated 15.06.2018 under the West Bengal Value Added Tax Act, 2003, and in partial modification of previous orders for allotment of duties amongst Special Commissioners and Additional Commissioners, the following order is made:

1. Smt. Sarbani Chatterjee, Additional Commissioner of Revenue and Special Officer, Bureau of Investigation, in addition to duties already allotted to her shall also be responsible for administration and overall monitoring of different Zones under Bureau of Investigation – Unit 1.
2. Sri Subrata Chaudhuri, Additional Commissioner of Revenue and Special Officer, Bureau of Investigation, in addition to duties already allotted to him shall also be responsible for administration and overall monitoring of different Zones under Bureau of Investigation – Unit 2.

Additional Commissioner of Revenue and Special Officer, Bureau of Investigation-Unit 2 shall also be responsible for administration and overall monitoring of Central Section-Kolkata, Barrackpore Range, Howrah Range and Kharagpur Range.

3. Sri Surendra Kumar Meena, Special Commissioner, GST in Durgapur, and Special Officer, Bureau of Investigation, in addition to duties already allotted to him shall also be responsible for administration and overall monitoring of different Zones under Bureau of Investigation – Unit 3.

Special Commissioner of Revenue and Special Officer, Bureau of Investigation-Unit 3 shall also be responsible for administration and overall monitoring of Central Section-Asansol, Purulia Range, Rampurhat Range and Durgapur Range.


4. Smt. Priyanka Singla, Special Commissioner, GST in Siliguri, and Special Officer, Bureau of Investigation, in addition to duties already allotted to her shall also be responsible for administration and overall monitoring of different Zones under Bureau of Investigation – Unit 4.

Special Commissioner of Revenue and Special Officer, Bureau of Investigation-Unit 4 shall also be responsible for administration and overall monitoring of Central Section-Siliguri, Siliguri Range, Alipurduar Range and Raiganj Range.

5. The on-going anti-evasion works already undertaken and presently being monitored by Bureau of Investigation Unit-1, Unit-2 or Unit-3 created under Notification No.

284-F.T. dated 12.03.2013, shall stand transferred to Bureau of Investigation Unit-1, Unit-2, Unit-3 or Unit-4 of the respective jurisdiction, as reorganised in terms of Notification No. 795-F.T. dated 15.06.2018, with immediate effect.

This order shall come into force with immediate effect.
