2. Monthly hire charge of the set including cost of fuel, operation charges, service charges and all charges is to be quoted clearly in application forms.
3. The authority reserves the right to accept or cancel any application forms without assigning any reason thereof, incomplete and incorrect application forms will face rejection summarily and reasons thereof will not be communicated to the intending suppliers/applicants.
4. The consolidated monthly hire charges once accepted can't be enhanced or altered dues to any reason whatsoever during this period.
5. The authority also reserves the right to discontinue the contract at any time with the one month notice.
6. The supplier shall be bound to repair or replace the set/s instantly, if it is found inoperative at any time during the material period.
7. The supplier is to follow strictly the order of Govt. prescribed for the purpose.
