**SUB: Hiring of 62.5 KVA Diesel Generator set at Commercial Tax Building, Durgapur for the period F.Y. 2018-2019.**

Sealed quotations are invited from suitable persons/concerns regarding installation and operation of 62.5 KVA diesel Generator set on monthly hire basis at Commercial Tax Building, City Centre, Durgapur, for the period F.Y. 2018-2019.

The hiring charges should be inclusive of all incidental costs to be incurred for installation and running of the Generator as and when required. The Generator has to be kept ready for operation round the clock throughout the year, and should be of good make and in good condition. All pollution control measures and sound-norms applicable as per existing regulations must be adhered to.

No hire charge will be entertained if the Generator fails to work in any day and in a part of full day for the defaulting period. No compensation/cost of accidental damages of the generator or operator will be borne by this office. The contract may be terminated by 15(fifteen) days notice by the undersigned without showing any reason. If the contractor desires to discontinue the contract, he shall be bound to intimate the undersigned at least three (3) months prior to discontinuation. All taxes, charges and duties etc. as applicable shall be payable by contractor.

Copies of GST & Profession Tax registration certificate, Adhaar card, PAN card, Voter card & Trade licence valid for the current financial year must be attached with the quotation. Copy of receipt showing payment of up-to-date profession tax is also to be attached.

The quotations in triplicate are to be submitted by 11/07/2018 within 3.00 PM at the office mentioned hereinabove and will be opened on 12/07/2018 at 1.00 PM.

It is to be noted that quoting the lowest amount may not be considered as the only criterion for recommendation; viability, experience and past records will also be taken into consideration. The authority reserves the right to accept or reject any of the quotations or withdraw the notice without assigning any reason whatsoever.
