NOTICE

Quotations are hereby invited by the under signed from bonafied owner of the motor vehicles permit as contract carriage, who are to supply the motor vehicle on hire basis for use in office of the Senior Joint Commissioner, Commercial Taxes, Jalpaiguri Circle, Jalpaiguri, on the following terms and conditions:-

1. CATEGORY OF VEHICLE – Motor vehicle (Non A/c) of all makes and model with diesel engine excluding Contessa or imported vehicle registered as luxury motor car.
2. THE HIRE CHARGES should be paid as per current rate approved by Transport Department, Govt. of West Bengal in their notification No. 3564-WT/3M-81/98 dated 24/11/2008.
3. THE OWNER OF THE VEHICLE, who is/are willing to keep the car in the office throughout the office days and the driver should available on call during the day and in any emergency.
4. PAYMENT of the car will be made on monthly hiring basis of Rs. 490/- per day (i.e. office days / working days) plus fuel @ 1 litre per 10 K.M., Mobile @ 5 Litre per 2500 K.M and hiring charge @ Rs. 18/- per hour beyond first 10 hours.
5. THE OWNER OF THE VEHICLE should immediately replace the car by another one in case the hired vehicle becomes out of order.
6. THE OWNER OF THE VEHICLE should bear all cost for smooth running of the car such as providing Driver, Fuel, Maintenance and all other related costs.
7. No such charges for journey of the car from the garage to reporting place and releasing place to garage will be paid.
8. The condition of the vehicle, behavior of the driver and overall service to be main criteria in the matter of selection and allowing continuation of service.
9. The application should be accompanied with the copy of road permit to carry passengers for hire on regard (commonly known tourist taxi) which is valid from 01 Apr 2018 to 31 Mar 2019 and copy of the Challan showing payment of Profession Tax for the year 2018 – 2019.
10. THE AGREEMENT FOR HIRING of the car will remain valid upto 31 Mar 2019. However, the hiring of the motor vehicle may be discontinued at any time during the above period within 15 days notice given beforehand without assigning reason whatever.
11. THE SEALED QUOTATION along with the photocopy of the relevant papers of the vehicle should reach in the office of the undersigned by 11:00 AM on 05th December 2018 positively. The e-mail ID and phone / mobile no. of respective bidder should reflect on the sealed envelope.
12. THE DECISION of the undersigned in the matter of selection will be final.
13. THE OWNER OF THE MOTOR VEHICLE, if his vehicle is selected for use in the office of the undersigned, shall be intimated in writing on or before 10th December 2018.
