The details hardware requirements including specifications of machine and terms & conditions for supply are mentioned in Annexure A & B respectively.


- Monochrome printing/copying

- The quotations duly signed should be submitted in sealed cover marked **"QUOTATIONS FOR SUPPLY OF PHOTOCOPIER MACHINE"** with all relevant information and supporting documents, mentioning contact no., e-mail id and address of the supplier, prescribed with brand/ name of machine etc. to the drop box kept in ground floor of main building of Office of the Commissioner of Commercial Taxes at 14, Beliaghata Road, Kolkata-700015 by 23th April, 2018 at 5-30 PM. If the envelope containing quotation documents are not found sealed, it will be summarily rejected and the Purchaser will assume no responsibility for rejection of the bid.
- The tenderer must possess valid GST registration and PAN in its name and mention these numbers.
- Bidders shall quote and accept payment in Indian Currency.
- The bid documents including detail hardware/software specifications are to be signed by authorised signatory of the tenderer with stamp duly affixed.
- A tender, which does not fulfil any of the above requirements and/or gives evasive information / reply against any such requirement, shall be liable to be rejected.
- Normally the supply contract will be awarded to the agency providing lowest quotation subject to fulfilment of the entire technical specifications mentioned in Annexure-A above. However, the Directorate of Commercial Taxes reserves the right to change the required specifications or even cancel the tender process at any

- time during the process of selection without assigning any reason to the participating tenderer.
- g. The tenderer will submit a photocopy of this tender notice duly sign and stamped a token of acknowledgement of the terms and condition of the tender.
- h. The representative of the tenderer may be present at the time of opening of tender on 24th of April, 2018 at 4-30 p.m. at the Office of the Commissioner of Commercial Taxes at 14, Beliaghata Road, Kolkata-700015.
- i. The selected supplier will supply and install the machine at the office of the Directorate of Commercial Taxes at Jalasampad Bhawan, Block-DF, Sector-I, Salt Lake City, Kolkata-700091 within fifteen days from the date of order for supply failing which it may be blacklisted.
- j. No advance payment will be made for supply, installation and commissioning of the photocopier machine. After satisfactory supply, installation and commissioning of the photocopier machine the supplier will raise its bill showing GST separately charged. The successful supplier has to furnish its mobile number and Bank Account number, Name of Bank & Branch, IFSC Code, etc for payment. The payment will be directly transferred to given bank account after processing of the bill.
